In view of the recommendation made by the inspecting officer to District Educational Officer, Kottayam in the reference 1<sup>st</sup> read above and after careful examination of the proposals with reference to the conditions prescribed in G.O. 1<sup>st</sup> to 4<sup>th</sup> read above, the District Educational Officer, Kottayam hereby awards grant of Temporary Recognition for a period of 10 years from the academic year 2012-2013 to 2021-2022 for classes I to V with its scope of Little Flower School, Kottayam, Kannad District.

Subject to the following conditions:-

1. The schools shall abide by the Instructions / Orders / Regulations made by the Government / Appointed Officer time to time.
2. The District Educational Officer shall verify the needs of the locality more particularly.
3. The Government shall adopt the particular and syllabus presented from time to time.
4. The School timings, vacations and mid-term holidays shall be as prescribed by Government from time to time.
5. The staff employed within the age limits prescribed by the Government for Government Employees shall be appointed as per the staff pattern.
6. The salary scales of teachers shall be satisfactory every year.
7. The accounts / statements shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September of the year.
8. The list of governing body shall be furnished to the District Educational Officer, every year.
9. The Fee Structure / Fee Structure Band by the governing body shall be got approved by the District Educational Officer every year.
10. The all the conditions prescribed in the G.O. and other orders, which are not specified in the order shall be complied with.
11. The schools shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least 5 months before.
12. The school shall not be closed or permitted to be closed only from the date on which closure is declared.
13. The management should not run higher classes.
14. The schools shall submit proposals for removal of Provisional Recognition efficiently in advance i.e., at least 5 months prior to the date of expiry of the order. These orders are liable for withdrawal / cancellation at any time for non-compliance of conditions of temporary recognition.

The receipt of the proceedings shall be acknowledged.
